Freeport Indonesia President Director Makes Courtesy Call to Central Papua Acting Governor

Nabire – In initiating cordial partnership relations with Central Papua Provincial Government, on Tuesday (28/03/2023) PT Freeport Indonesia (PTFI) President Director Tony Wenas and PTFI Senior Management made a courtesy call to Central Papua Provincial Government.
